

Minor Student Release of Liability, Assumption of Risk, and Promise Not to Sue

IMPORTANT: THIS DOCUMENT AFFECTS LEGAL RIGHTS. PLEASE READ IT COMPLETELY BEFORE ACCEPTING AND SIGNING.

This agreement applies to the Student and parent or legal guardian identified in this registration. It covers the Student's participation in ordinary Persian Learning Center Inc. ("PLC") programs and activities occurring during the 12-month period beginning on the date this agreement is electronically signed. Covered activities include Persian-language and cultural instruction, classroom activities, arts and crafts, music, rehearsals, performances, celebrations, community programs, and supervised indoor, outdoor, recess, or playground activities.

This agreement applies at PLC program locations, class sites, event locations, classrooms, playgrounds, parking areas, entrances, sidewalks, common areas, and designated drop-off and pickup areas where the Student participates in, attends, or is present for a PLC program or activity.

I certify that I am the Student's parent or legal guardian and have authority to sign this agreement. I give permission for the Student to participate in the covered PLC programs and activities. I understand that participation is voluntary and may involve risks, including slips, trips, falls, classroom or playground accidents, contact with other children or adults, arts and crafts activities, food or allergy exposure, illness or communicable-disease exposure, property loss or damage, parking and pickup-area risks, emergency situations, the Student's actions or inactions, actions or negligence of other participants or third parties, and conditions existing at a PLC program or location.

I understand that these risks may result in physical or psychological injury, pain and suffering, illness, disfigurement, temporary or permanent disability, paralysis, emotional or economic loss, property damage, or death. I knowingly and voluntarily assume the known and unknown risks ordinarily associated with the Student's participation in, attendance at, or presence during PLC programs and activities.

In consideration for the Student being permitted to participate in, attend, or be present at PLC programs and activities, I, on behalf of myself and, to the fullest extent permitted by California law, on behalf of the Student and our respective heirs, next of kin, representatives, and assigns, release and discharge Persian Learning Center Inc. and its directors, officers, employees, instructors, volunteers, agents, and contractors from claims arising from physical or psychological injury, illness, death, property damage, or economic or emotional loss connected with the Student's participation in or presence at a PLC program, activity, location, or designated drop-off or pickup area.

THIS RELEASE INCLUDES CLAIMS CAUSED IN WHOLE OR IN PART BY THE ORDINARY NEGLIGENCE OF ONE OR MORE OF THE RELEASED PARTIES, TO THE FULLEST EXTENT SUCH CLAIMS MAY LAWFULLY BE RELEASED UNDER CALIFORNIA LAW. I agree not to bring or maintain a lawsuit or claim that falls within the lawful scope of this release.

This agreement does not release or excuse gross negligence, reckless or willful misconduct, intentional misconduct, fraud, or any violation of law or statutory duty that cannot legally be waived under California law. Nothing in this agreement is intended to waive any right or claim that California law does not permit a parent, legal guardian, or Student to waive.

I understand that I am responsible for safely transporting, dropping off, and picking up the Student at the locations and times designated by PLC. Unless PLC expressly agrees otherwise in writing, PLC's supervision begins when the Student is properly signed in or accepted by authorized PLC personnel and ends when the Student is signed out or released to a parent, legal guardian, or authorized pickup adult. PLC is not responsible for the Student before the designated sign-in time, after sign-out or release, while traveling to or from a PLC program, or while outside the designated PLC program area.

I authorize PLC to release the Student only to a parent or legal guardian identified in this registration or an authorized pickup adult listed by me. PLC may require identification before releasing the Student, and I am responsible for keeping the authorized pickup information accurate and current.

Field trips and PLC-arranged transportation require separate written permission from the Student's parent or legal guardian. This general registration alone does not authorize either.

This agreement is governed by California law. If any provision is determined to be invalid or unenforceable, that provision will be limited or removed only to the extent necessary, and the remaining provisions will continue in effect.

I have read this agreement in its entirety, understand its legal effect, and accept it freely and voluntarily. I am not relying on any statement or representation about this agreement other than what is written in this document.

I agree to complete this registration and waiver electronically. I intend my electronic signature to have the same effect as my handwritten signature. I understand that PLC may preserve my submitted information, consent selections, electronic signature, and submission date and time. I have had the opportunity to read, print, download, or otherwise retain this agreement before signing it.
